NOTIFICATION


The University has adopted the UGC (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018, as published in the Official Gazette of India on 31.7.2018, as received vide UGC vide Lr. No. F-1-18/2010 (CPP) dated 6.8.2018 (Copy enclosed) for its students, researchers, faculty and staff of MANUU as notified by the University vide Notification No. ER.1(B)/F.282 dated 21st December, 2018.

2. In pursuance of the decision taken in the Executive Council in its 72nd Meeting held on 27.12.2018 vide Resolution No. 72.5.2, the Vice-Chancellor is pleased to constitute the Institutional Academic Integrity Panel (IAIP) as required under clause 11 of the University Grants Commission (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018 as under:-

The IAIP shall be assisted by the Section Officer, ER.I Section.

3. The IAIP shall function as per the provisions of UGC (Promotion of Academic Integrity and Prevention of Plagiarism in Higher Educational Institutions) Regulations, 2018.

4. The tenure of the Committee members including the Chairperson shall be three years. The quorum for the meetings shall be three out of four members including the Chairperson.

5. The IAIP shall follow the principles of natural justice while deciding about the allegation of plagiarism against the student, faculty, researcher and staff of the University. The IAIP shall provide a copy of the report to the person(s) against whom inquiry report is submitted.

6. The IAIP shall send the report after investigation and the recommendation on penalties to be imposed to the Vice-Chancellor within a period of 45 days from the date of receipt of the reference/complaint/initiation of the proceedings.
