

CIRCULAR

Sub: MANUU - Administration & Governance - Medical Reimbursement Regulations, 2010 - Revision of rates of monthly subscription w.e.f. 1.4.2018 & Amendment regarding removal reiling in medical reimbursement

The Executive Council in its 66th Meeting held on 15.2.2018 considered the changes in the existing Medical Reimbursement Regulations 2010 related to full reimbursement of medical expenses as per CGHS rates and Review of monthly subscription rates for serving and retired employees. The following decisions were taken:-

(i) Amendment in the existing Medical Reimbursement Regulations, 2010:

Repeal of Sub-clause 1 of Clause VI under which a ceiling of two month's basic pay in a calendar year was fixed by the University for reimbursement of outpatient medical treatment, to align with the provisions of CS (MA) Rules of Govt. of India.

(ii) Revision of the existing monthly subscriptions w.e.f. 1.4.2018 under three different Group of employees (teaching & Non-teaching) as under:-

Classification of posts (Teaching/Non-Teaching)	Existing monthly subscription w.e.f. 1.1.2010	Revised rates of monthly subscription w.e.f. 1.4.2018
Group A	Rs. 200/-	Rs. 400/-
Group B	Rs.100/-	Rs. 300/-
Group C & erstwhile Group D	Rs. 100/-	Rs. 200/-

(iii) Rates of subscription to be payable by the retired MANUU employees for availing the reimbursement benefits under the MANUU Medical Reimbursement Regulations, 2010

Adoption of rates of subscription prescribed under Office Memorandum No. S.11011/11/2016-CGHS (P)/EHS, dated 5th January 2017, issued by the Government of India, Ministry of Health & Family Welfare (EHS Section) to be payable by the retired employees of MANUU who were contributing towards either GPF or NPS and are in receipt of monthly pension from the University under Old pension scheme or NPS, for availing medical facilities under the MANUU *Medical Reimbursement Regulations 2010*. The revised rates shall be applicable w.e.f. 1.1.2017. MANUU pensioners shall have an option to get their Pensioner Medical Card made by either making a lump sum contribution on annual basis (12 months) or by making contribution for 10 (ten) years (120 months) for getting a Pensioner Medical Card with lift-time validity.
