

NOTIFICATION

The Executive Council in its 74th Meeting held on 17.5.2019 (vide Resolution No. 74.4.3) considered the recommendations of the Academic Council (AC) in its 34th Meeting held on 7.3.2019 in which it was resolved by the AC for the inclusion of the Directors and Professors of the Centres as Members in the respective School Board in view of the re-organization of University Centres. The existing composition of the School Board was earlier approved by the Academic Council in its 26th Meeting held on 28.4.2017 (vide Resolution No. 26.5.01).

- Accordingly, the revised composition of the School Board of the School of Arts 2. & Social Sciences (SA&SS), School of Education & Training(SE&T) and School of Languages, Linguistics and Indology (SLL&I) as required under Statute 16(2) of the Statutes of the University shall be as under:-
- Deans of the School of Studies (Chairperson); (i)
- All the Heads of Departments under the School of Studies concerned; (ii)
- All the Directors of the Centres attached to the School of Studies concerned; (iii)
- All Professors under the School concerned; (iv)
- Senior most Associate Professor in each teaching Department/Institutions by (V) rotation for a period of two years;
- Senior most Assistant Professor in each teaching Department/Institutions by (vi) rotation for a period of two years;
- Two Professors from other Schools nominated by the Vice-Chancellor; (vii)
- Three external members to be nominated by the Vice-Chancellor for a period (viii) two years; of
- Principal/In-charge of Colleges/Institutions/Polytechnics# (ix)
 - (#) subject to austerity measures to be adopted as per Circular No. MANUU/ER.I (DL)/F.30/2018-19/1543/1 dated 6.2.2019.
- Inclusion of new members in the School Board as per the revised constitution 3. wherever necessary shall be processed by the Deans of Schools concerned through Academic Section for the approval of the Vice-Chancellor.



4. Further the Academic Council in its last Meeting (35th) held on 16.5.2019 noted that there were delays in holding the School Board Meetings by some Deans of Schools. As per the draft Ordinance earlier approved by the Executive Council the ordinary meetings of the School Board is required to be convened twice a semester so that to consider the recommendations of Board of Studies of Department concerned (Copies attached for ready reference). All the Deans of Schools are, therefore, advised to adhere to the schedule prescribed by the AC & EC as far as possible in this regard.
