NOTIFICATION

Sub: Revision in the rates of remuneration to Academic Counselors, Coordinators, Support Staff of Learner Support Centres of Directorate of Distance Education for PG/UG/B.Ed. programmes.

Reference is invited to University's Notification No. MANUU/Acad/F.67(XXX)/2018-19/R-04 dated 16th April, 2018 on the above subject wherein rates of remuneration to Academic Counselors, Coordinators, Support Staff of Learner Support Centres of Directorate of Distance Education for PG/UG/B.Ed. programmes were revised with effect from 1st April, 2018. In the course of establishing Learner Support Centres in Colleges and Universities under new University Grants Commission (Open & Distance Learning) Regulations, 2017, several institutions had raised concerns at the existing rates of remuneration. Accordingly, the Vice-Chancellor had constituted a Committee to look into the matter.

2. Based on the recommendations of the Committee and considering the imperative need to immediately make the Learner Support Centres functional under the new Regulations of UGC, it has been decided to partially revise the rates of remuneration of academic and other staff as an interim measure subject to further review as detailed below:
