Master's Programme in Economics:(Course Structure, Rules & Regulations, Admission process, Intake, Eligibility and Detailed Course Outlines)

The Chairperson of the Committee initiated the discussion by outlining the course structure, rules and regulations, admission criterion, intake capacity, eligibility conditions and course outlines of the Master's Programme. Then Dean(SA&SS)highlighted some general issues and suggested various ways, all members took part in the discussion, deliberated upon each issue particularly course structure and course outline and approved all the contents of the items under the agenda with suggested modifications.

Committee resolved the following:

1. Any optional paper would be offered to the students if the number of students is at least five
2. Mathematics for Economics renamed as Quantitative Methods
3. Industrial Economics should be made compulsory paper in semester III and Rural Economics should become Optional Paper
4. Islamic Banking renamed as Islamic Banking and Finance
5. In semester IV, Research Methodology should be added as compulsory paper
6. In semester IV, Master's Thesis should be of 100 Marks only and the marks will be structured as following
 - 50 Marks on Thesis Writing
 - 30 Marks Viva-Voce
 - 20 Marks on Presentation



Bachelor of Arts Programme :(Course Structure and Course outlines of Economics)
