MAULANA AZAD NATIONAL URDU UNIVERSITY (MANUU) GACHIBOWLI EXPRESSION OF INTEREST (EOI)

- 1. The Registrar, MANUU Gachibowli, Hyderabad invites Expression of Interest (EOI) from the registered Civil contractors authorized/qualified to quote for works up to 15 lakh and having valid registration in CPWD/ Telengana State PWD/MES / Railways/ Central/State Autonomous Bodies/Departments of appropriate class for empanelment of agencies for repair, maintenance and minor works, costing less than Rs. 15.00 lakh and found eligible as per the minimum requirements defined in clause 2 below.
 - i) Last Dates & time EOI open for issue/download: up to 26/12/2018up to 3.00 P.M.
 - ii) Last date & time of submission of EOI (Hard copies only): 28/12/2018 up to 3.00 PM
 - iii) Time & date of opening of EOI: At 3:30 PM on 28/12/2018
- The applicant should be a registered civil contractor authorized/qualified to quote for the works up to 15.00 lakh and having valid registration in CPWD- Class- V/ Telengana State PWD/ MES/Railways/ Central/State Autonomous Bodies/Departments of appropriate class for empanelment of agencies for repair, maintenance and minor works costing up to Rs. 15.00 lakh at MANUU, Gachibowli and fulfilling following requirements:
- 2.1 Should have valid Registration Certificate with specified departments i.e. (CPWD/ Telengana PWD/MES/Railways/ Central/Sate Autonomous Bodies) in respective category trade and appropriate class.
- 2.2 Should have satisfactorily completed three similar works each costing Rs 6 lakh or two similar works each costing Rs 9 lakh or one similar work costing Rs 12 lakh completed during the last seven years ending 31/03/2018 out of which at least one work should have been completed in Govt. Department or Govt. undertaking or Govt. Autonomous Organizations institutions/Educational Institutions.
 - The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7 % per annum, calculated from the date of completion to the last date of receipt of applications for tenders. Similar work means: Construction/maintenance of: Civil- Building works including internal water supply, sanitary installations and drainage and AR/MO building works.
- 2.3 Agency should also submit copy of valid PAN & GST registration certificates/numbers.
- 2.4 Agencies not meeting the minimum eligibility criteria shall be summarily rejected.
- 3. MANUU Gachibowli, reserves the right to restrict the number of empanelled agencies out of technically qualified agencies/EOI applications received.
- 4. EOI documents may be obtained from the Engineering Section, Room No 15, Admin Building, MANUU Gachibowli, Hyderabad -500 032 from- 18/12/2018 to 26/12/2018 between 10.00 AM to 3.00 PM or may directly be downloaded from the MANUU Gachibowli website: www.manuu.ac.in at free of cost during the above period.

5. Submission of EOI Documents

- 5.1 The EOI submitted by the agency shall comprise the following:
 - a) Valid registration/enlistment with specified departments, valid PAN & GST, registration certificates/numbers per Para 2 above.
 - b) Income Tax returns of the last three years.
 - c) Information in Formats A, B &C as specified as per Annexure 1 and any other information required to be completed and submitted by Bidders in accordance with these instructions.
 - d) Audited annual accounts for last three previous years.
- 5.2 The EOI in prescribed form duly completed and signed shall be submitted in a sealed cover. The sealed cover Super-scribed "EOI document for the EMPANELMENT OF REGISTERED CONTRACTORS FOR EXECUTION OF WORKS AT MANUU-GACHIBOWLI". EOI must be dropped in the tender box at Room No 15, Admin Building, MANUU Gachibowli, Hyderabad -500 032 on or before 28/12/2018 up to 15:00 hours.
- 5.3 EOI will be opened on 28/12/2018 at 15.30 hours in the presence of the intending Bidders who wish to attend. If the office happens to be closed on the date of receipt of the EOI as specified, the EOI will be received and opened on the next working day at the same time and venue. EOI sent by post should reach MANUU Gachibowli on or before 28/12/2018up to 15:00 hours

6. **EOI Validity**

- 6.1 The EOI submitted shall remain valid for acceptance for a period of 60 days from the date of opening of the EOI.
- 7. The Registrar, MANUU Gachibowli shall be the "Competent Authority" here in after referred to as such for the purpose of empanelment process.

8. **EVALUATION CRITERIA:**

The details submitted by the bidders will be evaluated in the following manner:-

- 8.1 The bidder should meet minimum eligibility criteria prescribed in clause 2 above in respect of experience of similar class of works completed etc.
- 8.2 Even though a bidder may satisfy the above requirements, he would be liable for disqualification if he has:
 - (a) Made misleading or false representation or deliberately suppressed the information in the forms, statements and enclosures required in the pregualification document.
 - (b) Records of poor performance such as abandoning work, not properly completing the contract, or financial failures / weaknesses etc.
- 8.3 The University is at no obligation to call for the tenders from a particular empanelled agency(is). Mere empanelment of the contractor does not confer any right for being called for the tenders.
- 8.4 The University shall at its convenience may review the status of empanelled contractors for their continued empanelment or deletion from the panel evey six months and may, if need be, call for EOI for addition of fresh contractors in the panel.
- 8.5 The University shall have the power to remove a contractor from the panel who remain non-responsive to three consecutive tenders invited by the University and for which the contractor is eligible to bid.

8.6 The empanelled contractors has to respond to the tenders independently and colliding with other contractors will entail the contractor to debar from the empanelment.

8.7 The evaluations, calling for tenders, award of works and execution are subject to the Govt. of India. General Financial Rules 2017 as prescribed for execution of

works.

9. Clarification of Bids

9.1 To assist in the evaluation of EOI, the MANUU, Gachibowli may at its discretion ask any Bidder for clarification of his EOI.

9.2 No, Bidder shall contact the MANUU, Gachibowli on any matter relating to his EOI from the time of the EOI opening to the time the empanelment list is declared by MANUU Gachibowli.

9.3 Any effort by the Bidder to influence the MANUU's EOI evaluation may result in

the rejection of his EOI.

10. Maulana Azad National Urdu University, Gachibowli, does not bind itself to accept the EOI, and reserves the right to reject any or all of the EOI received without assigning any reasons.

11. Empanelment Criteria

11.1 The MANUU, Gachibowli shall empanel the registered contractors for three years whose evaluated EOI has been determined to be the technically suitable and the Bidder is determined to be qualified as per EOI document. The competent authority of MANUU Gachibowli, reserves the right to accept or reject any application and to annul the empanelment process and reject all applications at any time, without thereby incurring any liability to the affected applicants or specifying the grounds for the Employer's action.

1.2 EOI applicants shall be informed about their technical qualification or

disqualification.

- 11.3 MANUU Gachibowli Empanelment decisions shall be final and binding on the EOI applicants and no claim/representation about technical qualification or disqualification from EOI applicants shall be entertained by MANUU, Gachibowli.
- 12. All information called for in the enclosed forms should be furnished against the respective columns in the forms. If information is furnished in a separate document, reference to the same should be given against respective columns. Such separate documents shall be chronologically placed at the end of the prescribed application. If information is 'nil' it should also be mentioned as 'nil' or 'no such case'. If, any particulars/query is not applicable in case of the applicant, it should be stated as 'not applicable'. However, the applicants are cautioned that not giving complete information called for in the application forms required, not giving it in clear terms or making change in the prescribed forms or deliberately suppressing the information may result in the applicant being summarily disqualified.

The applicant should submit the letter of transmittal attached with EOI document.
