Prof. Salma Ahmed Farooqui was appointed as Professor-Deccan Studies vide orders 2nd cited against one vacant post of Professor sanctioned by UGC for Centre for Deccan Studies vide its letter 1st cited.

- 2) Prof. Salma Ahmed Farooqui, Professor-Centre for Deccan Studies was appointed as Director, Centre for Deccan Studies under Section 2(f) read with Statute-8 of the University Act for a period of 3 years or until further orders whichever is earlier with effect from 11.09.2014 vide orders 3rd cited. Her three years term of appointment as Director expiring on 10.09.2017.
- 3) That the Executive Council at its 49th meeting held on 08.11.2014 approved the re-designation of the post of Professor of Deccan Studies as Professor-cum-Director, Deccan Studies.
- That the matter regarding expiry of the term of Prof. Salma Ahmed Farooqui as the Director of the H.K. Sherwani Centre for Deccan Studies was subsequently reviewed by the Executive Council (EC) in its 63rd Meeting held on 7.9.2017. The EC observed that the UGC had initially sanctioned one post of Professor along with other three faculty positions for the Centre for Deccan Studies vide UGC letter No.F.1-1/2013 (CU), dated 5.2.2014. The University notified one vacant post of Professor-Deccan Studies vide employment notification dated 23.5.2014 against which Prof. Salma Ahmed Farooqui was appointed w.e.f. 11.9.2014. Therefore, the EC was of the view that the change of nomenclature of the post of Professor of Deccan Studies into Professor-cum-Director-Deccan Studies, Centre for Deccan Studies (now known as H.K. Sherwani Centre for Deccan Studies) as resolved earlier by the EC in its 49th Meeting held on 8.11.2014 was not proper as no prior approval from the UGC was taken by the University before such change of nomenclature of the post or redesignation.

- 5) That after detailed deliberations and going through the relevant records connected to the above matter, the EC resolved that the original nomenclature of the post of Professor Deccan Studies as sanctioned by the UGC vide letter dated 5.2.2014 (against the appointment of Prof. Salma Ahmed Farooqui has been made) was to be restored. Consequently, Prof.Salma Ahmed Farooqui shall continue as Professor Deccan Studies against the original sanctioned post for the Centre for Deccan Studies, approved by the UGC.
- 6) That the EC further resolved to authorize the Vice Chancellor to make alternative arrangements in the post of Director, H.K. Sherwani Centre for Deccan Studies, after the expiry of three years term of Prof. Salma Ahmed Farooqui.
- Prof. Now, in view of the ending the term of appointment of Prof. Salma Ahmed Farooqi, the Vice Chancellor in pursuance of the decision taken by the Executive Council at its 63rd meeting held on 07.09.2017 and in exercise of powers conferred on him, under the University Act, Statutes of the University, is pleased to appoint Prof. Mohd. Naseemuddin Farees, Dean, School of Languages, Linguistics & Indology, having regard to his expertise in Deccani Language & Literature as the Director, H.K. Sherwani Centre for Deccan Studies w.e.f. 11.9.2017, initially for a period of one year or until further orders whichever is earlier, in addition to his normal duties.
