Sub: Release of House Rent Allowance to teaching and non-teaching staff of MANUU- Furnishing of mandatory Certificate for claiming HRA - regarding

The University has been following Government of India (GoI) rules and regulations/guidelines for grant of H.R.A. to its teaching and non teaching employees. As per the existing instructions issued by the Ministry of Finance, Department of Expenditure vide OM No. 1113/2/86-E.II(B) dated 23.9.1986 as applicable to central government employees, every Government servant should furnish along with his/her first claim for HRA a certificate in form as per the prescribed format. Any payment of HRA to a Government employee shall be only on the basis of furnishing of such certificate on individual basis.

- It has been observed by the competent authority that HRA is being released by the University without complying with the above Ministry of Finance instructions and without obtaining the requisite certificate from the employees who are drawing HRA.
- 3. It is, therefore, decided to obtain the necessary certificate in the prescribed format from all those employees who are presently drawing HRA. All the employee concerned are hereby requested to furnish the certificate to the ER.I or ER.II Section as the case may be either through hard copy or signed copy sent through email latest by 15.7.2019. A copy of the certificate is uploaded along with this circular on the website.
- It may be noted that HRA shall be released only on the receipt of the said certificate failing which they are not entitled to HRA from the month of July, 2019 onwards.
