Sub: Your letter dated 28.07.2017

Dear Sir,

With reference to your letter of 28th July 2017 signed by all the Office Bearers except General Secretar, y has been received. The reply is as under:

1. That the representations, as mentioned in your letter and submitted to my office, were addressed jointly in the official reply sent on 17th January 2017 and as acknowledged in your letter also. You have written that in this letter some assurances were given to resolve the issues but none is resolved or orders released.

Kindly note that about issues at sl. no.1,4,5,7 and 12, it was clearly mentioned that as per the rules these issues cannot be entertained hence no assurance was given. However, issue no.3,4 and 5 were discussed again at length in our 11th April 2017 meeting and it was decided that these will be placed before the Executive Council for consideration (vide letter No.MANUU/ER-I(B)/F.249/2017-18/37 dated 12th April 2017). For item no.6 & 8, it was mentioned that they are examined and clarifications are sought from concerned committees/authorities. Eleven issues related to transport allowance to staff, teaching practice, travel grant for Seminars, etc; ALMANAC of the University, work assignment to different teachers, promotion of certain teaching faculties, composition of Board of Studies, uploading of notices, information about Workshops, Conferences, etc., making buildings friendly to physically challenged people and Off Campuses, were clarified. For issue at sl.no.24 we approached UGC but have not heard from them despite reminders. With response to the issue at sl.no.9, a notification was immediately released and the same was done for empanelment of hospitals as well as for allowances. You may refer to the letter of 17th January which contains in detail, the point wise response for further clarifications. Therefore, your statement that the assurances were given and nothing done is not correct.

2. In the meeting held on 11th April 2017 many issues were resolved. You are wrong here to say that meeting was not fruitful. In fact subsequent to our meeting on 11th April 2017, five circulars/notifications were released on the very next day i.e., 12th April 2017, while sixth one was issued on 28th April 2017 dealing with the special compensatory allowance (Hill area).

3. I wish to remind you that in the subsequent meeting with you and the entire executive, you all not only appreciated the promptness of our response but also said that you were not expecting that such a quick response would be given. In fact on 12th April 2017 at 3:30 p.m. you sent a message to me on my Whatsapp number where in you have appreciated that we have kept our promises and accepted your suggestions. I am enclosing a copy of your message for ready reference. This message was sent in Urdu. Similarly on 30th April 2017 you sent a message to me in English appreciating the further steps which we have taken as per the decisions made during our meeting. I am pained to see the difference in your (entire executive's) personal and public posturing and statements.

In fact I am surprised that after so much appreciation and holding a very productive meeting wherein we explained the University's decisions and clarified that those issues which are not as per the rules of either University/ UGC/ Government of India, cannot be accepted.

Last but not the least, I wish to draw your attention to the Executive Council's Resolution No.52.4(xiii) which is quoted as under:

"Strike Notice should not be given without the consensus and approval of the General Body of the Association with valid issues/problems passed by the General Body of the concerned Association"

In light of this resolution kindly submit to my office the resolution passed in your General Body Meeting which calls for a "Relay Hunger Protest on 8th August 2017 on wards or Dharna" along-with the list of attendees with their clear names and signatures who have passed this resolution.

In the end I would like to mention that we all are working hard day and night to improve the working of the University and to improve upon our existing academic level and work culture. The progress which has been made in the recent past has been appreciated by one and all, particularly the outside agencies and people. That the University is gaining acceptance in the Urdu Community is reflected very well, mainly in the increased number of applications received and record number of students admitted this year and it must be noted that all the students admitted as also all the people appointed through the Selection Committees are Urdu knowing and very competent. Therefore I request you, your entire Executive and all the members to please strengthen our hands and contribute your due towards development of this Institution and work in the interest of the University. Do not plan to initiate those steps which are against the rules and interest of the University.
