- 2. The above revision of the allowances has been made applicable to the regularly appointed teachers, equivalent academic staff, Registrar, Finance Officer and Controller of Examination in MANUU with the approval of the Executive Council of the University 3<sup>rd</sup> cited, subject to the following conditions:
  - The allowances with revised rates shall be effective from 01.07.2017.
  - ii) Payment of arrears will be released after the funds for the purpose are provided by the UGC to MANUU.
  - iii) A copy of MHRD and UGC order 1<sup>st</sup> and 2<sup>nd</sup> cited are enclosed for information.
  - iv) The Finance Officer may release the allowances with revised rates to the regular teachers, equivalent academic staff, Registrar, Finance Officer and Controller of Examination for the month of March, 2019 onwards.
- 3. Arrears arising out of the above revision of allowances shall be payable to the Teachers and Officers concerned.

Subject: Revision of allowances of teachers, equivalent academic staff, Registrars, Finance Officers and Controller of Examination in Universities and colleges as per recommendations of 7<sup>th</sup> CPC-regd.

Sir.

In continuation of this Ministry's letter No.1-7/2015-U.II(1) dated 02.11.2017 and letter No.1-7/2015-U.II(2) dated 02.11.2017, it is informed that that the Government of India have decided, in consultation with the Ministry of Finance (Department of Expenditure), to revise the rate of allowances of teachers, equivalent academic staff, Registrars, Finance Officers and Controller of Examinations in Central Universities and colleges thereunder and Centrally funded Deemed to be Universities on the basis of recommendations of the 7th Central Pay Commission, with immediate effect.

- 2. It has been decided that the rates of the allowances admissible during the 6<sup>th</sup> CPC shall be revised in accordance with the provisions of the Department of Expenditure's OM No.1/1/2016-E-III(A) dated 26<sup>th</sup> July, 2017, read with Department of Expenditure's Resolution dated 06.07.2017 and the Government orders issued in the matter, for teachers, equivalent academic staff, Registrars, Finance Officers and Controller of Examinations in Central Universities and colleges thereunder and Centrally funded Deemed to be Universities.
- 3. It is also informed that the rate of Special Allowances for the post of Vice-Chancellor, Pro Vice-Chancellor and College Principals has been revised by a factor of 2.25 and the revised Special Allowances are as follows:
