
**Important Instructions:**

4. Valid caste/ category certificate (format prescribed by Government of India) if applicable
5. Four passport size latest color photographs of Candidate
6. One photograph each of Parents/ Guardian
7. One copy of the Adhar card (UID)

**Notes:**

1. Call for counseling doesn't guarantee admission. Admission is subject to availability of seats in respective categories.
2. The original certificates of admitted candidates will be retained in the institute till the completion of the training period. Hence the candidates are advised to keep sufficient Xerox copies before submitting the original certificates.
