

## Dear Boarders,

This is to bring to your kind notice that in view of the UGC guidelines, the examination of the Final year students of the academic year 2019-20 shall be held compulsorily before September 2020, therefore, the earlier Notice dated 06th July 2020 has been withdrawn. Accordingly, the University has decided to schedule the examinations of final year students from 07th September 2020 onwards. After depositing the due amount, the students may send the **Scanned Copy of the Deposit Slip** to **(provostofficegh.mess20@gmail.com)**. Further, students must provide the details like- Name of the Student, Class, Mess No., Mobile No., Room No. and name of the Hostel in the e-mail.

In case, if the pending Mess Dues is not cleared on or before 20th August, 2020, the Hall Tickets of the students of the Final Year will be withheld till the student clears his pending mess dues.

Moreover, there are many students whose **excess amount towards mess deposits** has to be refunded by the Provost Office. The details of the students and refunded amount will be shared in girls hostel whats app group.
