The intending bidders may furnish their quotations on-line through Central Public Procurement Portal (CPPP) at http://eprocure.gov.in/eprocure/app only along with Earnest Money Deposit (EMD) Declaration Certificate as per Annexure – 3 before 15.00 hrs (time) of 02.03.2021 (date).

Terms and Conditions of Tender

1. **Submission of bids**

- The technical and financial bids should be furnished in Annexure-1 and Annexure-2 1.1 respectively and both the bids should be submitted online @ https://eprocure.gov.in/eprocure only along with the requisite documents.
- 1.2 Scanned copy of relevant documents/ certificates in support of fulfilling the eligibility criteria must be submitted along with the technical bid failing which the technical bid shall be rejected.
- 1.3 The tender document (both technical and financial) should be submitted online only.
- 1.4 Bidders should quote the prices on-line for printing of SLM as per ANNEXURE-2 only. The quotes should be inclusive of transport, packing, labour etc. and valid for a minimum period of 75days from the closing date of the tender.
- 1.5 Bidders shall have to ascertain the exact percentage of GST applicable on each of the items while quoting the rates in the financial bid (ANNEXURE-2). In case of discrepancy / difference of opinion on GST rates, the University shall decide the lowest quotation on verification of the relevant provisions of GST Act vis-à-vis supporting documents provided by the bidders in respect of the claim for the GST. In case of ambiguity on percentage of GST applicable, the University will award the contract on the basic price i.e excluding GST quoted in the online price bid. The decision of the University shall be final and binding in this regard. The items are exclusively for the DDE MANUU for education and research purpose only and not for commercial use.

2. **Submission of EMD Declaration Certificate**

- 2.1 The firms should submit EMD Declaration Certificate on the firms letterhead and upload on CPPP along with Technical bid document.
- 2.2 In Case of submission of declaration of exemption from EMD, and if the firm did not complete the contract or denies / withdrawing during the bid validity period, MANUU shall have the right to blacklist the firm for 2 years for all MANUU tender with effect from issue of this tender.

3. Opening of bids

- 3.1 Technical bid would be opened online only and scrutinized as per the eligibility criteria prescribed.
- 3.2 Financial bids of only technically qualified bidders will be opened by the authorized officers of the University.
- 3.3 The technical bids shall be evaluated based on the documents submitted by the bidders in totality as required under clause 4 above. To assist in the examination, evaluation, comparison of the bids and qualification of the bidders, the MANUU may, at its discretion, ask any bidder for a clarification on its bid. Any clarification submitted by a bidder that is not in response to a request by the MANUU shall not be considered. The MANUU's request for clarification and the response shall be in writing.
- If a bidder does not provide clarifications of its bid by the date and time set in the University 3.4 request for clarification, its bid may be rejected.
- MANUU also reserves its right to seek confirmation / clarification on the supporting 3.5 documents submitted by the bidder from the agency(ies) issuing such document(s).
- 3.6 The online bid opening, evaluation, award of contract etc will be made as per CPPP norms only.
- 3.7 The quotation should be valid for a minimum period of 75 days from the closing date of tender.

4. Pre-qualification (eligibility) criteria

6. Supply of printed SLM

- 6.1 The process of printing and supply has to be completed within 30 days from the next working day of issue of Award of Contract.
- 6.2 The printed items should be delivered at DDE, MANUU, Hyderabad.
- 6.3 Quality check: The required quality (Brightness of Inner pages and GSM of Inner pages and title pages) may be got tested by the University through any Government recognized laboratory/ agency. The Committee shall randomly select 2 samples upto 500 quantity and 3 samples for more than 500 quantity samples from each title supplied for quality check. The approximate cost for testing charges of one SLM would be Rs. 650/-, (Testing of GSM of Cover page and Testing of GSM and Brightness of Inner pages) to be borne by the L-1 firm. In case of any deficiency being found, the University may, at its discretion take appropriate action as detailed below.

8. **Performance Security**

- 8.1 The selected firm should submit 3% of value of Award of Contract (AOC) as Performance Security in the form of Account Payee Demand Draft / Fixed Deposit Receipt from commercial bank / Bank Guarantee from a Nationalized / commercial bank in favour of MANUU payable at Hyderabad.
- The above security should be furnished within fourteen days of issue of Award of Contract.
- 8.3 The security is liable to be forfeited and credited to University's account in the event of breach of any of the terms and conditions set out herein.
- The Performance Security will be returned without interest after 60 days from the date of 8.4 fulfilment of all contractual obligations.

9. **Payment**

- 90% value of total printing and supply of the work order: After 100% print and (i) supply of SLM subject to certification of receipt of quantity and acceptance by the University officials concerned.
- 10% value of total printing and supply of work order: Remaining 10% after quality checks of inner pages and cover page subject to quality meeting the specifications mentioned at clause 5.1.
- 9.2 No advance payment shall be made to the printer / supplier.

10. Liquidated damages

- 10.1 Failure to supply the Self Learning Material as per Schedule of Requirements including any subsequent addition/ reduction made thereto within the period stipulated in clause 6.1 shall entitle the Procuring Entity (MANUU) to charge liquidated damages @ ½% (half percent) per day on the quantity undelivered within the prescribed time frame covered in the Award of Contract, subject to a maximum of 5% (five percent), after expiry of the stipulated time period of the supply unless extension is obtained in writing from the University on Valid ground before expiry of delivery period. This deduction of penalty would be in addition to the penalty (if any) as per certification of quality check.
- 10.2 If the deliveries are not maintained and Procuring Entity is forced to buy the material from elsewhere, the loss or damage that may be sustained due to such buying would be recovered from the defaulting supplier.

11. Miscellaneous

- 11.1 The contract will be awarded to the firm who quotes L1 in item wise (i.e. book wise). In the case of two or more firms quoting the same L-1 rate, in such situation, the University shall call revised & fresh quotations from such firms only with short duration.
- 11.2 The items being procured are for exclusive use of MANUU. Use of printed material in any form or for any purpose by the printer will entail legal action.
- 11.3 In the event of L1 bidder not being capable of performing the printing and supply of Self Learning Material in entirety as per notified specifications within the stipulated time frame as required by the University, the competent authority of the University reserves the right to split the work and award a portion of it to L2 bidder at accepted L1 rate if he agrees to do so. Otherwise the offer will pass on to L3 bidder and so on. The decision of the University in this regard will be binding on the bidders.
- 11.4 Quoting of price: The prices are to be quoted for the printing of books on per book basis only [inclusive all, as per the above specifications, pages (blank & printed), binding, transport, packing, labour etc.,]. In case of any variation of number of pages noticed at later stage, the proportionate amount per page will be deducted / considered. The bidders may check the material available, location, type of printing of inner/cover page etc., before submission of the tender document.

Termination of contract

Dispute Resolution

- 13.1 Any dispute arising out of non-observance of terms and conditions by either party shall be resolved through mutual consultation and decision of the University shall be final and binding on both the parties.
- 13.2 In case of any legal remedy required, the jurisdiction of court will be Hyderabad.


